MEMBERS OF PARLIAMENT (ENTITLEMENTS) COMMISSION (AMENDMENT) REGULATIONS 2018

The Members of Parliament (Entitlements) Commission, under section 69B(2) of the *Constitution*, make the following Regulations:

Part 1 Preliminary matters

1 Citation

These Regulations may be cited as the *Members of Parliament* (Entitlements) Commission (Amendment) Regulations 2018.

2 Commencement

These Regulations commence on 1 April 2018.

3 Meaning of "principal Regulations"

In these Regulations, "principal Regulations" means the Members of Parliament (Entitlements) Commission Regulations 1988.

4 Regulation 34 amended – new provision inserted after subregulation (1)

Regulation 34 of the principal Regulations is amended by inserting a new provision after subregulation (1) as follows:

- "1A (1) An Ordinary Member of Parliament who does not own a residential accommodation in Honiara must be provided with accommodation approved by the clerk when attending a Parliament meeting.
- (2) An Ordinary Member of Parliament must, within 2 days after the close of a Parliament meeting, vacate any accommodation provided ("provided accommodation") to him or her under subregulation (1).
- (3) An Ordinary Member of Parliament who fails to vacate provided accommodation within 2 days after the close of a Parliament meeting ("the 2 days") must be personally liable for any further expenses for the provided accommodation after the lapse of the 2 days."

5 Regulation 34 amended – new provision inserted after subregulation (1)

Regulation 34 of the principal Regulations is amended by inserting a new provision after subregulation (2) as follows:

"2A An Ordinary Member of Parliament who occupies his or her own residential accommodation in Honiara when attending a Parliament meeting is entitled to a monthly housing allowance of \$15,000 depending on the type, size and state of upkeep as approved by the clerk."

6 Regulation 34 amended – new provision inserted after subregulation (4)

Regulation 34 of the principal Regulations is amended by inserting a new provision after subregulation (4) as follows:

- "(5) In this Regulation, an "Ordinary Member of Parliament" means a Member of Parliament who:
 - (a) is not the Prime Minister; and
 - (b) does not hold the office of a Minister, Leader of the Opposition, Leader of the Independent Group, Deputy Speaker, Chairman of the Parliamentary Caucus or Chairman of any Parliamentary standing committee."
