PRICE CONTROL ACT (Cap. 64)

PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES (AMENDMENT) (NO. 7) ORDER 2020

I, **Hon. Clezy Rore**, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order.

1. This Order is the Price Control (Application to the Goods and Restriction of Prices) (Amendment) (No. 7) Order 2020.
2. This Order commences on 1 April 2020.
3. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (L/N 47 of 1987 is amended in Schedule 3 by deleting the item for serial No. 13 (Petroleum Products and substituting:

“13 PETROLEUM PRODUCTS
