FOREST RESOURCES AND TIMBER UTILISATION (FELLING LICLENCES) (AMENDMENT) (NO. 1) REGULATIONS 2018

IN exercise of the powers conferred by section 44 of the *Forest Resources and Timber Utilisation Act*, I, **Hon. Samuel Manetoali**, Minister for Forestry and Resource makes the following Regulations.

1. Citation

These Regulations may be cited as the Forest Resources and Timber Utilisation (Felling Licence) (Amendment) (No. 1) Regulations 2018.

2. Commencement

These Regulations commence on the date of publication in the Gazette.

3. Principal Regulation amended

Regulation 10A is amended as follows:

"delete the full stop in sub regulation (i) after the word "respectively" and add these words "or kauri species from Vanikoro Islands and plantations across the country."

add the word "or kauri" after the word "tubi" in subregulation (iii).

add the word "or kauri" after the word "tubi" in subregulation (iv)."

FOREST RESOURCES AND TIMBER UTILISATION (PROTECTED SPECIES) (AMENDMENT) (NO. 1) REGULATIONS 2018

IN exercise of the powers conferred by section 44 of the *Forest Resources and Timber Utilisation Act* (Cap. 40), I, **Hon. Samuel Manetoali**, Minister for Forestry and Research makes the following Regulations:

1. Citation

These Regulations may be cited as the Forest Resources and Timber Utilisation (Protected Species) (Amendment) (No. 1) Regulations 2018.

2. Commencement

These Regulations must commence on the date of publication in the *Gazette*.

3. Principal Regulation amended

The principal regulation is amended by inserting a new subregulation (2) after Regulation 5A (1) as follows:

"(2) For purposes of avoidance of doubt, only the Constituency is allowed to enter, cut, fell, skid, haul, grade, bond, loading to freighters the kauri species from Vanikoro Island and any plantation across the country."
