#### **ELECTRICITY ACT**

(Cap. 128)

### ELECTRICITY (CHARGES FOR SUPPLY) (No. 7) REGULATIONS 2025

I, Hon. Derick Rawcliff Manu'ari, Minister for Mines, Energy and Rural Electrification, and I, Hon. John Tuhaika Jnr, Minister for Finance and Treasury, under section 55(v) of the *Electricity Act* (Cap. 128) and with reference to section 26 of the *State Owned Enterprises Act* 2007 (No. 7 of 2007), on the recommendation of the Authority, make the following Regulations:

#### 1 Citation

These Regulations may be cited as the *Electricity (Charges for Supply) (No. 7) Regulations 2025*.

#### 2 Commencement

These Regulations commence on the date of publication in the Gazette.

#### 3 Definition

In these Regulations:

"non-regular customer' means a customer who owns a generation facility and is connected through a kilowatt metre.

## 4 Charges for supply of electricity

The rates of charges for the supply of electricity from Authority public installations:

- (a) for prepaid customers are specified in Schedule 1; and
- (b) for postpaid customers are specified in Schedule 2; and

(c) for non-regular customers are specified in Schedule 3.

# 5 Repeal

The *Electricity (Charges for Supply) (No. 6) Regulations 2025* (Legal Notice No. 121 of 2025) are repealed.
