**EMERGENCY POWERS ACT
(CAP. 11)****EMERGENCY POWERS (COVID-19) (NO.2) REGULATIONS 2020****EMERGENCY POWERS (COVID-19) (EXEMPTION FROM
QUARANTINE PERIOD) (NO. 3) ORDER 2020**

I, **Hon. Manasseh Sogavare**, Prime Minister, under regulation 7(2)(a)(iv) of the *Emergency Powers (COVID-19) (No. 2) Regulations 2020* (Legal Notice No. 47 of 2020), and under section 36 of the *Interpretation and General Provisions of the Act* (Cap. 85), make the following Order:

1. Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period) (No.3)(Amendment) Order 2020*.

2. Commencement

This Order commences on the date it is published in the *Gazette*.

3. Amendment to Emergency Powers (COVID-19) (Exemptions from Quarantine Period) (No.3) Order 2020.

The *Emergency Powers (COVID-19) (Exemptions from Quarantine Period) (No.3) Order 2020* (Legal Notice No. 75 of 2020) (“**Principal Order**”) is amended by:

- (i) deleting paragraph 10 and inserting “(10) Michael Samuel Lee Crisford”; and
- (ii) deleting paragraph 15 and inserting the following:

“(15) Toni Marie Thompson; and

(16) Juliet Mary Foster”.
