(CAP. 11)****EMERGENCY POWERS (COVID-19) (NO.2) REGULATIONS 2020****EMERGENCY POWERS (COVID-19) (EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO.5) ORDER 2020**

I, Hon. **Manasseh Sogavare**, Prime Minister, under regulation 8(2) of the *Emergency Powers (COVID-19) (No.2) Regulations 2020* (Legal Notice No. 47 of 2020), make the following Order:

1. Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 5) Order 2020*.

2. Commencement

This Order commences on the date this Order is published in the *Gazette*.
