I, Hon. **Manasseh Sogavare**, Prime Minister, under regulation 8(2) of the *Emergency Powers (COVID-19) (No.2) Regulations 2020* (Legal Notice No. 47 of 2020), make the following Order:

1. Citation

This Order may be cited as the *Emergency Powers (Covid-19) (Exception for Entry into Solomon Islands) (No. 10) Order 2020*.

2. Commencement

This Order commences on the date this Order is published in the *Gazette*.

EMERGENCY POWERS (COVID-19) (NO.2) REGULATIONS 2020

**EMERGENCY POWERS (COVID-19) (EXEMPTION FROM QUARANTINE
PERIOD) (NO. 4) ORDER 2020**

I, Hon. **Manasseh Sogavare**, Prime Minister, under regulation 7(2)(a)(iv) and (3) of the *Emergency Powers (COVID-19) (No.2) Regulations 2020* (Legal Notice No. 47 of 2020), make the following Order:

1 Citation

This Order may be cited as the Emergency Powers (COVID-19) (*Exemption from Quarantine Period*) (No.4) Order 2020.

2 Commencement

This Order commences on the date this Order is published in the *Gazette*.

3 Exemption from Quarantine Period

- (1) The following persons are exempted from being quarantine at a quarantine station for the quarantine period:
 - (a) Kelvin Ross McDonald;
 - (b) Glen Cyril Elliott Solly;
 - (c) Susan Jean Smith;
 - (d) Natasha Lee Smith;
 - (e) Deborah Denise Rasmussen;
 - (f) Warren Danford Michael.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must, while in Solomon Islands:
 - (a) maintain physical isolation from any other person; and
 - (b) be accommodated at the Heritage Park Hotel, Mendana Avenue, Honiara, in a manner that physically isolates the person from any other person; and
 - (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the Government's quarantine procedures.
