1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No.18) Order 2018, and commences on 1 September 2018.
2. The Price Control (Application to Goods and Restriction of Prices) Order 1987 (Legal Notice 47 of 1987) is amended in Schedule 3 by deleting serial no. 13 (Petroleum Products) and substituting the following:
