DEPORTATION ORDER

I, **Hon. Clezy Rore**, Minister for Commerce, Industries, Labour and Immigration, under section 31(1)(c) of the *Immigration Act 2012*, order the deportation of **Aung Win Naing**, an unlawful non-citizen who has a duty to depart under section 28 of the Act, being satisfied that:

- (a) Aung Win Naing has been given a reasonable opportunity to voluntarily depart from Solomon Islands; and
- (b) it is reasonable to conclude that Aung Win Naing is unlikely to voluntarily depart Solomon Islands.

CENTRAL PROVINCE BUSINESS LICENCE ORDINANCE 2020

In exercise of the powers conferred by section 31 of the Provincial Government Act 1997, (Act No. 7 of 1997), the Minister for Provincial Government and Institutional Strengthening makes the following Ordinance:

Part 1 Preliminary matters

1 Citation

This Ordinance may be cited as the Central Province Business Licence Ordinance 2020.

2 Commencement

This Ordinance commences on publication in the Gazette.

3 Definitions

In this Ordinance:

“*Act*” means the Provincial Government Act J 997;

“*Assembly*” means the Central Province Provincial Assembly constituted under section 7 of the Act;

“*authorised officer*” means a person authorised by the Executive under section 20 of this Ordinance;

“*business*” means;

- (a) any activity carried out in order to make a profit; and
- (b) includes:
 - (i) provision of services; and
 - (ii) manufacturing; and
 - (iii) retailing; and
 - (iv) wholesaling; and
 - (v) harvesting or collecting of natural resources; and

- (vi) farming; and
- (vii) purchasing of goods within the province for the purposes for sale outside the province; and
- (viii) working on contract for another business; and
- (c) does not include being an employee or activities on or in a local market, or hawking;

“**Executive**” means the Central Province Provincial Executive;

“**premises**” mean any structure, building, the land on which it is situated and any adjoining land used in connection with the structure or building ;

“**Province**” means Central Province as defined under section 3 of the. Act;

“**Provincial**” means relating to Central Province;

“**Religious material**” means items directly related to the carrying out of religious services, such as wine, candles, dictionaries and bibles.

4 Purpose

The purpose of this Ordinance is to regulate and control the operation of businesses in Central Province for the purpose of protecting and promoting the people, culture, and environment of Central Province.

Part 2 Business Licence

5 Businesses must be licensed

A person must not operate a business in the Province unless that person holds a business licence.

6 Exemptions

- (1) This Ordinance does not apply to:
 - (a) the Central Province Investment Shares in Public Private Partnership arrangements;
 - (b) hawking or trading in local market marketing;
 - (c) fundraising where the proceeds are used solely for charitable, religious, educations, sporting or other community purposes; or
 - (d) selling of religious books and other religious material or paraphernalia.

7 Form of application

- (1) A person who intends to operate a business must apply for a business licence.

- (2) The application must be made:
 - (a) in the form prescribed in Schedule 1; and
 - (b) sent to the Provincial Secretary; and
 - (c) accompanied by the fee prescribed in Schedule 5.
- (3) A person who holds a business licence may apply to renew the licence.
- (4) The application must be made:
 - (a) in the form prescribed in Schedule 2; and
 - (b) sent to the Provincial Secretary; and
 - (c) accompanied by the fee prescribed in Schedule 5.
- (5) A business may be conducted one or more than one premises, each business must be separately licensed.
- (6) A person may not apply for a business licence under subsection (1) if the person :
 - (a) has not obtained the required national licences, permits or permissions for or relating to the person's business.
 - (b) in the case of foreign investment, intends to carry out business in a reserved or prohibited area; or
 - (c) intends to conduct a business in contravention of a national or provincial law.
- (7) A holder may not apply to renew a business licence under subsection (3) if the holder:
 - (a) has not paid the prescribed fee;
 - (b) has not obtained the required national licences, permits or permissions for a relating to the holder's business;
 - (c) in the case of foreign investment, is or will carry out business in a reserved or prohibited area; or
 - (d) is conducting or will conduct a business that contravenes or will contravene a national or provincial law.

8

Applications for mining and logging operations

- (1) Applications relating to mining or logging operations must be accompanied by copies of the following:
 - (a) the business's national licence issued by the Director of the Ministry responsible for Mines and Minerals and/or the Commissioner of the Ministry responsible for Forest Resources;
 - (b) approval from the Director of the Environment and Conservation Division to carry out the activities described in the business licence

- application and to which the national licence relates;
 - (c) a copy of the company's Environment Impact Assessment;(d) State of the Forest Report stating the baseline data and size of trees whether it is sustainable to fell trees or not to fell trees;
 - (e) the Province may request an independent assessment with any entity for purposes of protecting the natural environment both on land, sea and rivers; and
 - (f) any other documentation and information that the Provincial Executive may require in order to assess the potential impact of the activities for which a licence is sought.
- (2) The Executive must not issue a business licence for mining or logging operations unless the information specified in subsection (1):
- (a) is provided with the application; and
 - (b) has been considered by the Executive.
- (3) No licence shall be issued for mining or logging operations until or unless the information in subsection (1) is provided .

9 Decisions about application

- (1) The Provincial Secretary must deliver each application received by the Provincial Secretary to the Executive.
- (2) The Executive must:
- (a) approve the application;
 - (b) decline the application; or
 - (c) approve the application subject to any terms and conditions imposed under section 10;
- (3) When considering any application under subsection (1), the Executive must take into account:
- (a) the extent of involvement in the business by the people indigenous to Central Province and resident in the locality where the business is intended to be carried out; and
 - (b) the contribution the businesses will make to the people of Central Province; and
 - (c) the geographical area served by the business: and
 - (d) any other matter or matters affecting the interests of the people of Central Province and their environment ;
 - (e) if the application relates to mining or logging operations, the documents, information and material specified in subsection 8(1).
- (4) If the Executive is considering declining an application under subsection

2(b), it must first give the applicant:

- (a) notice of the reasons that the application might be declined ; and
- (b) a reasonable opportunity to make a submission or be heard on the matter

10 Terms and Conditions of business licence

- (1) The terms and conditions of a business licence are specified on the business licence.
- (2) It is a term or condition of a business licence that:
 - (a) the holder of a licence must comply with laws in force in the Province; and
 - (b) the holder may only conduct business on the premises specified in the business licence.
- (3) The Executive may by written notice amend or revoke any term or condition imposed under subsection (1).
- (4) In addition, the Executive may impose other terms and conditions on a business licence.

11 Duration of Licence

A business licence has effect from the date that it is issued until 31 March following date of issue.

12 Classification of business

- (1) If the executive approves an application, the provincial secretary must issue the business licence to the applicant; and
- (2) The business licence must be in accordance with Schedule 3.

13 Proof of business licences

The production of the business licence, or a certified true copy of the business licence, is proof that the business licence was properly approved and issued.

14 Register of business licences

- (1) The Provincial treasurer must keep a register of all:
 - (a) applications for a business licence;
 - (b) decisions made in respect of each application; and
 - (c) licences issued under this Ordinance.
- (2) The register must be open for public inspection during normal working hours at the place where it is kept.

15 Display of business licences

A business licence must be:

- (a) displayed in a prominent position in or on the business premises where the business the subject of the licence is conducted; and
- (b) must be available for public inspection during normal working hours.

16 Business licence not transferable

A business licence is not transferable.

17 Lost, Stolen or damaged business licences

The holder of a business licence that has been lost, stolen or damaged may, on payment of the prescribed fee, obtain a copy of the business licence certified by the provincial Secretary to be a true and collect copy of the business licence.

18 Suspension, caoce llatioo, or revocation of business licence

- (1) The Executive may suspend or cancel or revoke a business licence if the executive reasonably believes that the holder of the licence:
 - (a) has not comp lied with a tenn or condition of the business licence; or
 - (b) is carrying out their business in a manner that brings the province into disrepute.
- (2) If the Executive is considering suspending, cancelling a business licence under subsection (1), it must first give the holder:
 - (a) notice of the reasons why the suspension, cancellation is being considered; and
 - (b) a reasonable opportunity to make a submission and be heard on the matter.

19 Application for additional premises

- (1) A holder of a business licence may apply to the executive for approval to operate their business on additional premises.
- (2) The application must be:
 - (a) addressed and in accordance with Schedule 4; and
 - (b) be accompanied by the prescribed fee.

20 Authorised officers

- (1) The Executive may authorise a person (“authorised officer”) in writing to perform functions, duties and exercise powers under and in accordance

with the Ordinance.

- (2) The authorisation may be subject to conditions .
- (3) The Executive may vary or revoke an authorisation.
- (4) Any authorisation or variation or revocation of an authorisation, must be in writing and given to the authorised officer.

Part 3 Miscellaneous matters

21 Payment of prescribed fees

- (1) A prescribed fee must be paid into the provincial fund of the province established under section 37 of the Provincial Government Act 1997 (No 7. of 1997).
- (2) If an applicant does not pay the prescribed fee referred to in section 7, the Provincial secretary must not accept the application.
- (3) If the holder of a business licence does not pay a prescribed fee into the provincial fund the holder commits an offence under section 23 and, on the conviction of the holder of the offence, the business licence ceases to have effect.
- (4) Any fee due under this Ordinance must be paid into the Provincial Fund of Central province, as established under section 34 of the Act.

22 Recovery of fees

A prescribed fee or fine imposed under section 23 is a debt due and payable to the Province and is recoverable by the Attorney General in a court of competent jurisdiction.

23 Offences

- (1) Any person who operates a business without a valid business licence commits an offence is liable to a fine not exceeding:
 - (a) \$500.00 in the case of a first time offence; or
 - (b) 100% of the cost of the business licence that they failed to obtain in the case of a second, or repeat, offence.
- (2) Any person operating a business after receiving notification that their business licence has been suspended, cancelled or revoked is guilty of an offence and liable to a fine not exceeding 5% of the total cost of the relevant business licence for every day that the business operates illegally.
- (3) Any person who continues to operate a business having been found guilty

of an offence under either subsection (I) or (3), commits an offence is liable to a fine not exceeding 200% of the total cost of the business licence the subject of the offence.

- (4) Any person who obstructs a Police Officer or authorised officer commits an offence and is liable to a fine not exceeding \$2000.00.

24 **Repeal**

On the commencement of this Ordinance, the ordinance of the Province applying to business licences that were in force before this commencement are repealed.

25 **Transitional provision**

On the commencement of this Ordinance, a business licence issued under the previous business licence ordinance continues to have effect subject to, and as if it were issued under, this Ordinance until the expiry of the term of the licence specified in the licence

LICENCE CONDITIONS

1. This licence must be displayed at all times on the business premises or on the vehicle or vessel. (8)
2. This licence does not give any rights to enter land to operate the licensed business. You must get the landowners permission.
3. The licence holder must comply with the laws of the Solomon Islands and Central Province.
4. The licence holders must produce this licence on the request of any Police Officer, Community Officer or Authorised Officer.
5. If the licence is lost or destroyed, a duplicate licence may be applied for from the Provincial Treasurer and will be provided on payment of the appropriate fee.

6. If you wish to use additional premises, vehicles or vessels for your business, you must apply for additional business licence.
7. The holder of petroleum business licence shall not store and sell petroleum products within fifty metres from residential area.
8. The licence is not transferrable.
