## LAND AND TITLES ACT (Cap. 133)

## LAND AND TITLES (GENERAL)(AMENDMENT) REGULATION 2020

I, **Hon. Ishmael Mali Avui**, Minister for Land, Housing and Survey, under section 260 of *Land and Titles Act* (Cap. 133) and with reference to section 36 of the *Interpretation and General Provisions Act* (Cap. 85), make the following regulations:

#### 1 Citation

These Regulations may be cited as the *Land and Titles (General) (Amendment) Regulations 2020.* 

#### 2 Commencement

These Regulations commence on the date they are published in the Gazette.

#### 3 Amendment of Land and Titles (General) Regulations

These Regulations amend the *Land and Titles (General) Regulations* (Cap. 133) (*"Principal Regulations"*)

## 4 New regulation 3A

# "3A Conditions for registering instrument that Commissioner required to sign

The Registrar must not register an instrument that must be signed by the

Commissioner before it is registered unless;

- (a) the instrument has been signed by the Commissioner; and
- (b) the person who signs the instrument as the Commissioner is the person who holds the office of Commissioner when the instrument is registered.".
