EMERGENCY POWERS (COVID-19)(NO. 3) REGULATIONS 2020

**EMERGENCY POWERS (COVID-19)(EXEMPTION FROM
QUARANTINE PERIOD)(NO. 8) ORDER 2020**

I, **Hon. Manasseh Damukana Sogavare**, Prime Minister, under regulation 7 of the *Emergency Powers (COV/D-19)(No. 3) Regulations 2020* (Legal Notice 104 of 2020), make the following Order:

1 Citation

This Order may be cited as the Emergency Powers (COVID19)(Exemption from Quarantine Period) (No. 8) Order 2020.

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Exemption from quarantine period

- (1) The following persons are exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 31 August 2020 and 1 September 2020:

- (k) Daniel Francis Anthony Ross-Murphy;
 - (l) Aaron John Grocott;
 - (m) Nyssa Ann Tasker;
 - (n) Richard Cameron Vial;
 - (o) James Oliver Copsey;
 - (p) Karl Jefferson Hawker.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must, while in Solomon Islands:
- (a) maintain physical isolation from any other person; and
 - (b) be accommodated at the Heritage Park Hotel, Mendana Avenue, Honiara, in a manner that physically isolates the person from any other person; and
 - (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the Government's quarantine procedures.
