# SOLOMON ISLANDS NATIONAL SPORTING COUNCIL ACT (Cap. 166)

#### APPOINTMENT OF VICE-CHAIRMAN AND PRIVATE SECTOR MEMBERS

### EMERGENCY POWERS (COVID-19)(NO. 3) REGULATIONS 2020

# EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD )(NO.11) ORDER 2020

I, **Hon. Manasseh Damukana Sogavare**, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice 104 of 2020), make the following Order:

#### 1 Citation

This Order may be cited as the *Emergency Powers (COVID19)(Exemption from Quarantine Period) (No. 11) Order 2020.* 

#### 2 Commencement

This Order commences on the day it is published in the Gazette.

### 3 Exemption from quarantine period

- (1) The following persons are exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 3 September 2020:
  - (a) Brett James Futter;
  - (b) Zackary Aaron Cox;
  - (c) Sitaing Ringko;
  - (d) George Itty Biji.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must, while in Solomon Islands:
  - (a) maintain physical isolation from any other person; and
  - (b) be accommodated in a manner that physically isolates the person from any other person; and
  - (c) be transported from Honiara International Airport to the person's accommodation, and from the accommodation to the airport, in

accordance with the Government's quarantine procedures.



## FOREST RESOURCES AND TIMBER UTILISATION ACT (CAP. 40)

#### **EXEMPTION NOTICE**

I, Hon.
