## CUSTOMS AND EXCISE ACT (CAP. 121)

## CUSTOMS AND EXCISE (EXCISE DUTIES) (AMENDMENT) (NO. 3) ORDER 2018

- I, Hon. **Manasseh Damukana Sogavare**, Minister of Finance and Treasury, under section 7 of the *Customs and Excise Act* (Cap. 121) make the following Order:
- 1. This Order may be cited as Customs and Excise (Excise Duties) (Amendment) (No.3) Order 2018, and commences 1 January 2019.
- 2. The First Schedule to the *Customs and Excise Act* (Cap. 121) as replaced by Legal Notice No. 66 of 2018 is amended by:
  - (a) deleting the duty rate of "\$120.48" per kg in respect of tariff item E.1 (a) and substituting the duty rate "\$148.29" per kg; and
  - (b) deleting the duty rate of "\$0.4608 per stick" or "\$460.80 per kg" in respect of tariff item E.1 (b) and substituting the duty rate "\$0.5209 per stick or \$520.90 per kg".

## CUSTOMS AND EXCISE (EXCISE DUTIES) (AMENDMENT) (NO. 4) ORDER 2018

- I, Hon. Manasseh Damukana Sogavare, Minister for Finance and Treasury, under section 7 of the *Customs and Excise Act* (Cap. 121) make the following Order:
- 1. This Order may be cited as Customs and Excise (Excise Duties) (Amendment) (No. 4) Order 2018, and commences 1 July 2019.
- 2. The First Schedule to the *Customs and Excise Act* (Cap. 121) as replaced by Legal Notice No. 66 of 2018, is amended by deleting the duty rate of "\$148.29" per kg in respect of tariff item E.1 (a) and substituting the duty rate "\$185.36" per kg.
