### EMERGENCY POWERS (COVID-19)(NO. 3) REGULATIONS 2020

## EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS)(NO. 30) ORDER 2020

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 6(2) of the *Emergency Powers (COIVD-19)(No. 3) Regulations 2020* (Legal Notice No. 104 of 2020), make the following Order:

#### 1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 30) Order 2020.* 

#### 2 Commencement

This Order commences on the day it is published in the Gazette.

#### 3 Non-citizens who may enter Solomon Islands

The following persons may enter Solomon Islands on 24 September 2020 despite the prohibition against entry under regulation 6(1) of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020*:

- (a) Raymond Arthur George Horton;
- (b) Anthony Blair Ussher;
- (c) Edward James Lewis Da Silva;
- (d) Steven Milton Daechsel.

### EMERGENCY POWERS (COVID-19)(NO. 3) REGULATIONS 2020

## EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD )(NO. 13) ORDER 2020

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice 104 of 2020), make the following Order:

#### 1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 13) Order 2020.* 

#### 2 Commencement

This Order commences on the day it is published in the Gazette.

### 3 Exemption from quarantine period

- (1) The following persons are exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 23 September 2020:
  - (a) Raymond Arthur George Horton;
  - (b) Anthony Blair Ussher;
  - (c) Edward James Lewis Da Silva;
  - (d) Steven Milton Daechsel.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must, while in Solomon Islands:
  - (a) maintain physical isolation from any other person; and
  - (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other person; and
  - (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the Government's quarantine procedures.
