CORRECTIONS (NATIONAL BUILDING STANDARDS ACT 2025)**NOTICE 2025**

I, John Osmond Gilbert Muria (Jnr), Attorney-General, under section 14 of the *Legislation Act 2023* make the following corrections:

1 Citation

This Notice may be cited as the Corrections (National Building Standards Act 2025) Notice 2025.

2 Purpose

This Notice corrects errors to the text of the *National Building Standards Act 2025* as published in Gazette Edition No. 116 of 2025 (“**the Act**”).

3 Correction

The errors in the Act are corrected:

- (a) in section 4(d), insert the words “are relevant” after “Planning and Development Act (Cap. 154)”;
- (b) in section 21 (1)(d), substitute “Chief Planner” with “Chief Physical Planner”;
- (c) in section 36(b), substitute “1991” with “1998”;
- (d) in section 37(1), at the definition of “repealed Ordinance”, substitute “1991” where it first appears with “1998”;
- (e) in section 42, Section 5 amended, in proposed subsection (5)(b), substitute “given under section 18” with “under section 15”;
- (f) in section 50, Section 23 amended, substitute the full section 50 with the following:

“50 Section 23 amended

Section 23 of the Principal Act is amended by inserting:

- (a) in subsection (1)(a) “or the NBC has been complied with,” before “shall quash”; and
- (b) in subsection (1)(b) “or the NBC,” before “as the case

may be,”.
