**ELECTRICITY ACT**

(Cap. 128)

**ELECTRICITY (CHARGES FOR SUPPLY) (No. 10) REGULATIONS 2025**

I, Hon. Derick Rawcliff Manu'ari, Minister for Mines, Energy and Rural Electrification, and I, Hon. Rexon Annex Ramofafia, Minister for Finance and Treasury, under section 55(v) of the *Electricity Act* (Cap. 128) and with reference to section 26 of the *State Owned Enterprises Act 2007* (No. 7 of 2007), on the recommendation of the Authority, make the following Regulations:

**1 Citation**

These Regulations may be cited as the *Electricity (Charges for Supply) (No. 10) Regulations 2025*.

**2 Commencement**

These Regulations commence on 1 October 2025.

**3 Definition**

In these Regulations:

“**non-regular customer**” means a customer who owns a generation facility and is connected through a kilowatt metre.

**4 Charges for supply of electricity**

The rates of charges for the supply of electricity from Authority public installations:

- (a) for prepaid customers are specified in Schedule 1; and
- (b) for postpaid customers are specified in Schedule 2; and

(c) for non-regular customers are specified in Schedule 3.

## 5 Repeal

The *Electricity (Charges for Supply) (No. 9) Regulations 2025* (Legal Notice No. 254 of 2025) are repealed.
