#### **EMERGENCY POWERS (COVID-19)(NO. 3) REGULATIONS 2020**

### EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 36) ORDER 2020

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 6(2) and (2A) of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice No. 104 of 2020), make the following Order:

#### 1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 36) Order 2020.* 

#### 2 Commencement

This Order commences on the day it is published in the Gazette. 3 Noncitizens who may enter Solomon Islands
