I, Hon. **Manasseh Damukana Sogavare**, Minister for Finance and Treasury, under section of the *Customs and Excise Act* (Cap. 121) make the following Order:

#### 1. Citation

This Order may be cited as the Customs and Excise (Export Duty Rates for Round Logs) (First Quarter) (Amendment) Order 2019.

#### 2 Commencement

This Order commences on 1 January 2019.

## 3 Prohibited species

This Order does not have the effect of allowing the export of species which are prohibited for export as round logs under the *Forest Resources and Timber Utilization Act* (Cap.40) or any other ract.

## 4 Export duty listed in Schedule

The export duty payable on the export of round logs shall be calculated and determined according to the Schedule to this Order.

#### 5 Amendment of First Schedule

The First Schedule to the *Customs and Excise Act* (Cap. 121), as replaced by Legal Notice No. 66 of 2018, is amended in tariff item number 44.03 by replacing the rates of the previous Order with the rates in the Schedule to the Order.
