THE HONIARA CITY COUNCIL APPROPRIATION ORDINANCE 2026

ENACTED: By the Honiara City Council with the Assent of the Minister as follows:

- 1 This Ordinance may be cited as the Honiara City Council Appropriation Ordinance 2026 and shall come into effect on the date it is assented to the Minister of Home Affairs in accordance with section 35 (2) of the Honiara

City Act 1999.

- 2 The issue of the sum of Sixty-Six Million Two Hundred Thirteen Thousand to the services of the financial year ending 31 December 2026.
- 3 The sum specified in the preceding section shall be appropriated for the supply of heads and subheads specified in the schedule and in amounts respectively in relation hereto.

HONIARA CITY ACT 1999 (NO. 2 OF 1999)

HONIARA CITY (2026 FEES, RATES AND CHARGES) ORDINANCE 2025

In exercise of the powers under sections 21, 23, 34 and 35 of the *Honiara City Act 1999* (No. 2 of 1999), the Honiara City Council makes the following law:

1 Citation

This Ordinance may be cited as the *Honiara City (2026 Fees, Rates and Charges) Ordinance 2025*.

2 Commencement

This Ordinance commences on 1 January 2026.

3 Schedule 1

The fees, rates and charges specified in column 3 of the table in Schedule 1 are the fees, rates and charges to be imposed by the Honiara City Council in 2026 for the services, facilities and permits specified in column 2 of the table in the same row.

4 Schedule 2

(1) The fees specified in column 3 of the table in Schedule 2 are the fees to be charged by the Honiara City Council in 2026 for the business licenses specified in column 2 of the table in the same row.

(2) In Schedule 2:

“(FO)” means foreign owned;

“(LO)” means locally owned.

5 Repeal

The Honiara City Council (2025 Fees, Rates and Charges) Ordinance 2024 (Legal Notice No. 117 of 2024) is repealed.
