**PRICE CONTROL ACT**

(Cap. 64)

**THE PRICE CONTROL (APPLICATION TO GOODS AND  
RESTRICTION OF PRICES) (AMENDMENT) ORDER 2005**

IN exercise of the powers conferred by sections 4 and 6 of the Price Control Act, and after consultations with the Prices Advisory Committee, I, WALTON NAEZON, Minister of Commerce, Employment and Trade, do hereby make the following Order -

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) Order 2005 and shall come into operation on 2 February 2005.
2. Schedule 3 to the Price Control (Application to Goods and Restriction of Prices) Order 1987\* is hereby amended by deleting serial No. 13 thereof and substituting therefore the following -

**“13 PETROLEUM PRODUCTS**
