EMERGENCY POWERS (COVID-19)(NO. 3) REGULATIONS 2020

**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 23) ORDER 2020**

I, **Hon. Manasseh Damukana Sogavare**, Prime Minister, under regulation 6(2) and (2A) of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice No. 104 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID19)(Exception for Entry into Solomon Islands)(No. 23) Order 2020*.

2 Commencement

This Order commences on the day it is published in the Gazette.

EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2020

**EMERGENCY POWERS (COVID-19) (NO. 3) (RESTRICTION
OF MOVEMENT OF COMMERCIAL OR PRIVATE RECREATION
VESSELS) ORDER 2020**

I, **Hon. Manasseh Damukana Sogavare**, Prime Minister, under regulation 13(1)(a)(i) of the *Emergency Powers (COVID-19) (No. 3) Regulations 2020* (Legal Notice No. 104 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (No. 3) (Restriction of movement of Commercial or Private Recreation Vessels) Order 2020*.

2 Commencement

This Order commences on the day this Order is published in the Gazette.

3 Restriction of movement of commercial or private recreation vessels

The movement of the following vessels into Solomon Islands is restricted:

- (a) cruise liners;
- (b) yachts;
- (c) pleasure crafts;
- (d) any other vessel used for:
 - (i) commercial recreation; or
 - (ii) private recreation; or
 - (iii) travel.
