EMERGENCY POWERS (COVID-19)(NO. 3) REGULATIONS 2020

**EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO
SOLOMON ISLANDS) (NO. 26) ORDER 2020**

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 6(2) and (2A) of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice No. 104 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID19)(Exception for Entry into Solomon Islands)(No. 26) Order 2020*.

2 Commencement

This Order commences on the day it is published in the Gazette.
