## GAMING AND LOTTERIES (Cap. 139)

#### POKER/KENO MACHINES (CONTROL) REGULATION 2015

**IN** exercise of the powers conferred under section 6 of the Gaming and Lotteries Act, I, **Manasseh Maelanga**, Minister for Home Affairs in consultation with the Board hereby make these Regulations –

## Citation and commencement

1. These Regulations may be cited as the Poker/Keno Machines (Control) Regulation 2015 and shall commence on the date of publication in the *Gazette*.

## Difinition

2. In these regulations unless the context otherwise requires –

"poker/keno machine permit" means one exclusive poker, keno machine permit issued by the Board to any of the existing holder of a commercial gaming permit specifically to install and operate poker, keno machines in any approved premises with Honiara City.

#### Application for an exclusive poker keno machine permit

- **3.** (1) A holder of commercial gaming permit may apply to the Board for an exclusive poker keno machine permit to install and operate poker keno machines outside of its usual place of business within Honiara City.
  - (2) An application for an exclusive poker keno machine permit shall be made to the Board with a prescribed fee in Form D as set out in the Schedule to this Regulation.

## Approval and issuance of one exclusive poker keno machine permit within Honiara City

**4.** The Board shall approve and issue only one exclusive poker/keno machine permit within Honiara City.

### Application for Inspection of premises

**5.** (1) This holder of an exclusive poker/keno machine permit shall apply to the Board for inspection of premises other than its usual place of business prior to installation and operation of the poke/keno machines in that premises.

#### Board to inspect all premises

**6.** The Boardd after receipt of the application shall inspect all premises, a holder of an exclusive poker keno machine permit may wish to install and operate its poker keno machines therein.

### Board may impose terms and conditions

7. The Board may imposed terms and conditions on the permit holder for the operation of its poker keno machines in any approved premises.

#### Issuance of exclusive poker keno machine permit

**8.** The Board subject to regulation 4 shall issue one exclusive poker keno machine permit in Form B after payment of prescribed fee to the Board in Form D set out in the Schedule.

### Declaration of approved premises

- **9.** (1) Where the Board is satisfied that the premises referred to in this regulation is suitable for installation and operation of poker/keno machines, the Board shall advise the Minister, to declare that such premises to be an approved premises as required under the provisions of these regulations.
  - (2) The form for Declaration of approved Premises and games is set out in the Schedule to this Regulation.

#### Minister to nominate approved game

10. The Minister may be notice published in the *Gazette* nominate poker/keno as the only game that shall be conducted or played in that approved premises pursuant to these Regulations.
