(NO. 3 of 2013)****EXTENSION OF DECLARATION OF BIOSECURITY (EMERGENCY
AREA) (SOLOMON ISLANDS) ORDER 2017**

IN exercise of the powers conferred upon me by section 69(1) of the Biosecurity Act 2013, and having been satisfied on the advice of the Director of Biosecurity that there is evidence of the existence of the pest, Coconut Rhinoceros Beetle, (Guam Type), I, **Augustin Auga**, Minister of Agriculture and Livestock, hereby extend the Declaration in Legal Notice No. 311 and dated Wednesday 3rd May 2017 by declaring -

THE WHOLE OF SOLOMON ISLANDS**As a Biosecurity Emergency Area**

For a period of six (6) months from the 3rd day of November 2017.
