**THE FISHERIES ACT 1998**  
(No. 6 of 1998)**THE FISHERIES (LOCAL FISHING VESSELS) (AMENDMENT)**  
**REGULATIONS 2005**

IN exercise of the powers conferred by section 59 of the Fisheries Act, 1998, I, PAUL MAENU'U, Minister of Fisheries and Marine Affairs, do hereby make the following regulations -

1. These Regulations may be cited as the Fisheries (Local Fishing Vessels) (Amendment) Regulations 2005.

2. Regulations 4 and 5 of the Fisheries (Local Fishing Vessels) Regulations 1981\* are hereby deleted.

**THE FISHERIES ACT 1998**  
(No. 6 of 1998)**THE FISHERIES (AMENDMENT) REGULATIONS 2005**

IN exercise of the powers conferred by sections 25 and 59 of the Fisheries Act, 1998, read with regulation 3 of the Fisheries Regulations 1972, I, PAUL MAENU'U, Minister of Fisheries and Marine Affairs, do hereby make the following regulations -

1. These Regulations may be cited as the Fisheries (Amendment) Regulations 2005, and shall come into operation on the date of publication in the *Gazette*.

2. The Fisheries Regulations are hereby amended by deleting therefrom the Second Schedule and substituting therefor the following new Schedule -
