THE CIVIL AVIATION ACT (Cap. 47)

THE CIVIL AVIATION (DESIGNATION OF GROUND-HANDLING AGENTS) ORDER 2005.

IN exercise of the powers conferred by section 6 of the Civil Aviation Act, (Cap. 47) I, SIMEON BOURO, Minister of Communication, Aviation and Meteorology, do hereby make the following order -

- 1. This Order may be cited as the Civil Aviation (Designation of Ground-Handling Agents) Order 2005.
- 2. All Airlines approved by the Air Transport Licensing Authority are hereby designed to be ground-handling agents for all international and domestic air services in and for Solomon Islands.

The Order Designation Ground-Handling Agent* is hereby revoked.

THE INVESTMENT ACT (Cap. 142)

THE INVESTMENT (AMENDMENT) REGULATIONS 2005

IN exercise of the powers conferred by section 17 of the Investment Act, I, WALTON NAEZON, Minister for Commerce, Industries and Employment, and

in consultation with the Investment Board, do hereby make the following regulations -

- 1. These Regulations may be cited as the Investment (Amendment) Regulations 2005.
- 2. Schedule III to the Investment Regulations 1999* is hereby amended by deleting same and replacing it with the following new Schedule III as follows -

"SCHEDULE III

(Regulations 4,6,7,8 and 10)

FEES FOR INVESTMENT APPLICATION AND CERTIFICATES OF APPROVAL, ETC....

1.	An application for foreign investment, Technology or external agreement, Incentives, shares purchase or transfers, Variation, amendments to certificate.	\$400.00
2.	Granting of a Certificate of Approval in respect of approval investment.	\$4,000.00
3.	Granting of a Certificate of Approval in respect of foreign investment and technology or external agreements made in a single application.	\$5,000.00
4.	Amendment to a Certificate of Approval in respect of share purchase or transfer, variation or other amendments as applied for and approved.	\$2,000.00
5.	Granting of a Certificate of Approval in applications made especially for incentives only.	\$1,000.00
6.	Granting of Investment incentives in respect respect of a technology or external agreement.	\$2,000.00
7.	Application for amendment to Certificate of approval of any of its terms and conditions.	\$400.00
