EMERGENCY POWERS (COVID-19) (No. 3) REGULATIONS 2021**EMERGENCY POWERS (COVID-19) (EXTENSION OF QUARANTINE
ORDER NO. 17 OF 2021) (AMENDMENT) ORDER 2022**

I, Hon. Manasseh Damukana Sogavare, the Prime Minister, under regulation 36(1)(b) of *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), and with reference to sections 36(a) and 65(2) of the *Interpretation and General Provisions Act* (Cap. 85), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Extension of Quarantine Order No. 17 of 2021) (Amendment) Order 2022*.

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Amendment

This Order amends the *Emergency Powers (COVID-19) (Extension of Quarantine) (No. 17) Order 2021* (Legal Notice No. 385 of 2021) (“**Principal Order**”).

4 Paragraph 3 amended

Paragraph 3 of the Principal Order is amended by:

- (a) omitting “The quarantine period of each of the following person specified in the Schedule” and substituting:

“(1) The quarantine period of each person specified in Schedule 1”;
and

- (b) by inserting at the end:

“(2) The quarantine period of each person specified in Schedule 2, who entered Solomon Islands on 17 December 2021, is extended for 3 more days ending on 3 January 2022, and each person must be quarantined at a quarantine station during that three-day period.”.

5 Paragraph 4 amended

Paragraph 4 of the Principal Order is amended:

- (a) by omitting “Each of the person whose quarantine is extended under paragraph 3” and substituting:
 - “(1) Each person whose quarantine is extended under paragraph 3(1); and
- (b) by inserting at the end:
 - “(2) Each person whose quarantine is extended under paragraph 3(2) must be tested on 3 January 2022 for the presence of COVID-19 and must test negative for COVID-19 for the test.”.

6 **Schedule amended**

The Schedule to the Principal Order is amended:

- (a) by omitting from the heading “**Schedule**” and substituting “**Schedule 1**”; and
- (b) by omitting “(Paragraph 3)” and substituting “(Paragraph 3(1))”; and
- (c) by omitting the following subparagraphs:
 - (i) (1.5);
 - (ii) (1.6);
 - (iii) (1.8);
 - (iv) (1.9);
 - (v) (1.12);
 - (vi) (1.16);
 - (vii) (1.24);
 - (viii) (1.29).

7 **New Schedule 2**

The Principal Order is amended by inserting after the Schedule:

“SCHEDULE 2 (Paragraph 3(2))

- (2.1) Meiling Tokatake;
- (2.2) Mason Wei Fang;
- (2.3) Reginald Talasas;
- (2.4) Peter Sua;
- (2.5) Jack Smith;
- (2.6) Slimson Muna;

- (2.8) Dickson Toumae.”.
