**SOLOMON ISLANDS TERTIARY EDUCATION AND SKILLS AUTHORITY
(FEES) REGULATIONS 2024**

I, Hon. Tozen Leokana, Minister for Education and Human Resources Development, under section 55 of the *Solomon Islands Tertiary Education and Skills Authority Act 2017*, make the following Regulations:

1 Citation

These Regulations may be cited as the *Solomon Islands Tertiary Education and Skills Authority (Fees) Regulations 2024*.

2 Commencement

These Regulations commence on the date these Regulations are published in the Gazette.

3 Fees

A registered provider or applicant is required to pay the applicable fee set out in the Schedule.
