#### **ELECTRICITY ACT**

(Cap. 128)

#### **ELECTRICITY (CHARGES FOR SUPPLY) (NO. 9) REGULATIONS 2024**

I, Hon. Bradley Billy Smoky Rodo Tovosia, Minister for Mines, Energy and Rural Electrification, and I, Hon. Manasseh Damukana Sogavare, Minister for Finance and Treasury, under section 55(v) of the *Electricity Act* (Cap. 128) and with reference to section 26 of the *State Owned Enterprises Act 2007*, on the recommendation of the Solomon Islands Electricity Authority, make the following Regulations:

#### 1 Citation

These Regulations may be cited as the *Electricity (Charges for Supply) (No. 9) Regulations 2024.* 

#### 2 Commencement

These Regulations commence on 1 October 2024.

#### 3 Definition

#### In these Regulations:

"non-regular customer' means a customer who owns a generation facility and is connected through a kilowatt metre.

#### 4 Charges for supply of electricity

The rates of charges for the supply of electricity from Authority public installations:

(a) for prepaid customers are specified in Schedule 1; and

- (b) for postpaid customers are specified in Schedule 2; and
- (c) for non-regular customers are specified in Schedule 3.

#### 5 Repeal

The *Electricity (Charges for Supply) (No. 8) Regulations 2024* (Legal Notice No. 85 of 2024) are repealed.
