### PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) (NO. 14) ORDER 2024

- I, Hon. Harry Kuma, Minister for Commerce, Industry, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:
- 1 This Order may be cited as the *Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 14) Order 2024.*
- 2 This Order commences on the day this Order is published in the gazette.
- 3 The *Price Control (Application to Goods and Restriction of Prices) Order 1987* (Legal Notice No. 47 of 1987) is amended in Schedule 3 by revoking serial No. 13 (Petroleum Products) and substituting the following:

### PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) (NO. 15) ORDER 2024

I, Hon. Harry Kuma, Minster for Commerce, Industry, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

- 1 This Order may be cited as the *Price Control (Application to Goods and Restrictions of Prices) (Amendment) (No. 15) Order 2024.*
- 2 This Order commences on 3 September 2024.
- 3 The *Price Control (Application to Goods and Restriction of Prices) Order 1987* (Legal Notice 47 of 1987) is amended in Schedule 3 by revoking Serial No. 12 (Liquid Petroleum Gas) and substituting the following:
