**PRICE CONTROL ACT**  
(Cap. 64)

**PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) (NO. 17) ORDER 2024**

I, Hon. Harry Kuma, Minister for Commerce, Industry, Labour and Immigration, having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

- 1 This Order may be cited as the *Price Control (Application to Goods and Restrictions of Prices) (Amendment) (No.17) Order 2024*.
- 2 This Order commences on 21 October 2024.
- 3 The *Price Control (Application to Goods and Restriction of Prices) Order 1987* (Legal Notice 47 of 1987) is amended in Schedule 3 by revoking Serial No.12 (Liquid Petroleum Gas) and substituting the following:

**“12 LIQUID PETROLEUM GAS**

**PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) (NO. 18) ORDER 2024**

I, Hon. Harry Kuma, Minister for Commerce, Industry, Labour and Immigration,

having consulted the Prices Advisory Committee, under sections 4 and 6 of the *Price Control Act* (Cap. 64), make the following Order:

- 1 This Order may be cited as the *Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 18) Order 2024*.
- 2 This Order commences on 1 November 2024.
- 3 The *Price Control (Application to Goods and Restriction of Prices) Order 1987* (Legal Notice No. 47 of 1987) is amended in Schedule 3 by revoking serial No. 13 (Petroleum Products) and substituting the following:

**“13 PETROLEUM PRODUCTS**
