**ELECTRICITY ACT**

(Cap. 128)

**ELECTRICITY (CHARGES FOR SUPPLY) (NO. 11) REGULATIONS 2024**

I, Hon. Bradley Billy Smoky Rodo Tovosia, Minister for Mines, Energy and Rural Electrification, and I, Hon. Manasseh Damukana Sogavare, Minister for Finance and Treasury, under section 55(v) of the *Electricity Act* (Cap. 128) and with reference to section 26 of the *State Owned Enterprises Act 2007*, on the recommendation of the Solomon Islands Electricity Authority, make the following Regulations:

**1 Citation**

These Regulations may be cited as the *Electricity (Charges for Supply) (No. 11) Regulations 2024*.

**2 Commencement**

These Regulations commence on 1 December 2024.

**3 Definition****In these Regulations:**

“*non-regular customer*” means a customer who owns a generation facility and is connected through a kilowatt metre.

**4 Charges for supply of electricity**

- (a) for prepaid customers are specified in Schedule 1; and
- (b) for postpaid customers are specified in Schedule 2; and
- (c) for non-regular customers are specified in Schedule 3.

## 5 Repeal

The *Electricity (Charges for Supply) (No. 10) Regulations 2024* (Legal Notice No. 100 of 2024) are repealed.
