SOLOMON ISLANDS INDEPENDENCE ORDER 1978

(L.N. 43 of 1978)

TEMPORARY ASSIGNMENT OF RESPONSIBILITY TO THE MINISTER FOR CULTURE AND TOURISM

In exercise of the powers conferred by section 37 of the Constitution and acting in accordance with the advice of the Prime Minister, I, Reverend David Tiva Kapu, Governor-General and Commander-in-Chief of Solomon Islands, assign to the person from time to time holding the office of:

MINISTER FOR CULTURE AND TOURISM

the responsibility for the administration of the Ministry of Commerce, Industry, Labour and Immigration, and for the conduct of the business of the Government of Solomon Islands and for the statutory authorities specified in the Schedule, on and from 22 December 2024 to 5 January 2025.
