**MEMBERS OF PARLIAMENT (ENTITLEMENTS) COMMISSION  
(AMENDMENT) REGULATIONS 2016**

IN exercise of the powers conferred by section 69B(2) of the Constitution, the Members of Parliament (Entitlements) Commission makes the following Regulations:

**1 Citation**

These Regulations may be cited as the *Members of Parliament (Entitlements) Commission (Amendment) Regulations 2016*.

**2 Commencement**

These Regulations commence on the date they are published in the *Gazette*.

**3 Regulations amended**

These Regulations amend the *Members of Parliament (Entitlements) Commission Regulations 1988*.

**4 Amendment of regulation 9**

- (1) Regulation 9(3)(b)(i) is amended by deleting "or such other amount within the limits as approved by Parliament".
- (2) Regulation 9(3)(b)(ii) is amended by deleting "the whole or".
- (3) Regulation 9(3)(b)(ii) is amended by deleting "purposes" and substituting "purposes, which must not include financing home loan payments for any person,".

**5 Amendment of regulation 11D**

- (1) Regulation 11D(1) is amended by deleting "The" and inserting "With the exception of a recipient who is medically certified to be wholly dependent on care provided by another person and incapacitated, the".
- (2) Regulation 11D(1) is amended by deleting "When he ceases to be a Member" and substituting "When the recipient ceases to be a Member and reaches the age of 50 years".

**6 Amendment of regulation 33**

- (1) Regulation 33(1) is amended by deleting "request" and substituting "request and are not otherwise accommodated by the Government".
- (2) Regulation 33(1) is amended by:
  - (a) deleting "\$9,000" and substituting "\$15,000"; and
  - (b) deleting "\$15,000" and substituting "\$20,000".
- (3) Regulation 33(2) is amended by:
  - (a) deleting "\$9,000" and substituting "\$15,000"; and
  - (b) deleting "\$15,000" and substituting "\$20,000".

**7 Amendment of regulation 41**

Regulation 41(7) is amended by deleting "\$7,000" and substituting "\$15,000".

**8 Amendment of regulation 70**

Regulation 70(1) is amended by deleting "for fourteen or more consecutive days".
