PROVIDE FOR AN AMENDMENT TO THE WESTERN
PROVINCE AREA COUNCIL ORDINANCE 1985

ENACTED by the Western Provincial Assembly.

ARRANGEMENT OF SECTIONS

Section

1. Short Title and Commencement.
2. Part III, Qualification, Nomination and election.

1. This Ordinance shall be entitled the Western Provincial Area
Council (Amendment) Ordinance, 1985, and shall become effective
upon approval by the Minister in accordance with Section 32 of
the Provincial Government Act 1981.

Part III.

2. Principal Ordinance is amended by repealing Part III Sections 8, 9, 10, 11 and 12 and substituting the following -

"PART III

QUALIFICATION NOMINATION AND SELECTION

8. A person is a qualified candidate for membership as a selected member of an Area Council if that person -

- (a) is ordinarily resident in the community electorate area, such area to be defined in any election regulations made under Section 39 hereto.
- (b) is a Solomon Island citizen, and
- (c) has attained the age of eighteen years, and
- (d) is not disqualified under Section 25 of this Ordinance provided that:

a Public Officer or a Provincial Officer may qualify as a candidate but he must resign his post within the period of one month beginning with the time of his election

- (e) gives his consent to being a candidate.

Entitled to
Vote.

9. The persons entitled to vote at an Area Council election shall:

- (a) be a Solomon Island citizen; and
- (b) have attained the age of eighteen years;
- (c) be ordinarily resident in the community electorate area.

Conduct of
the Election.

10. The election of Area Council members shall be conducted in accordance with the Area Council Election Regulations.

Method of
Voting.

11. The methods of nomination and voting shall be in accordance with the Area Council Election Regulations.

Election of
Members and
Tenure of
Office.

12. (1) The date of the first ordinary election of members of the Area Council established by this Ordinance shall be decided by the Executive.

(2) Thereafter each ordinary election of Area Council members shall be held on the fourth anniversary of the date of first election.

(3) If the anniversary referred to in subsection (2) falls on an excluded day the election shall be held on the next subsequent day which is not an excluded day.

(4) In this Section "excluded day" in relation to an election means Saturday, Sunday and any day which is a Public holiday for the purposes of the Public Holidays Act, unless it is a day appointed under Section 6 of that Act for the purposes of the election.

(5) The term of office of any elected member of an Area Council, not otherwise disqualified for membership under Section 25 of the Ordinance, shall begin on the day he is elected and end with the dissolution of the Area Council.
